

V. Reports of Standing Committees

- a. Repeater Committee- Mike Pate
 - Ron Matusek Repeater committee needs to put out a report / summary of repeater activities regularly. This does not need to be bills, contracts or legal matters. But the membership needs to have a summarized update.
 - ii. Paul Kent
 - 1. The antenna mount was bent and one of the radials is missing. We haven't found the radial.
 - 2. The repeater seemed to work well the morning after the storm but degraded soon afterward (at least from the sound if it from Paul's QTH).
 - 3. The flexible coax between antenna feed point and the hard line appears pinched. Coax is pulled tight above the facade.
 - 4. Due to the location of the antenna, a professional climber must be used to retrieve and repair the antenna. A quote for \$1500 was sent to the board to retrieve/the damaged antenna for the repeater.
 - a. Climbers will also disconnect and retrieve the coax from the antenna to the hardline. They



- will also add the coax from the hardline to the new location for remounting the antenna.
- b. This does not include remounting a new (or existing)
- c. Recommendation to re-run a hardline coax and to re-mount the antenna on a mount on an I-beam that is accessible without a climber.
 - i. This must be reviewed by the building management before implementation

d. QUESTIONS

- i. *Rich Kent*: Will building management approve the adjustments?
- Paul Kent: The building management will need to respond to the proposal before moving forward.
- e. Ron Matusek We will wait until the building management responds to vote on spending for the climber.
- 5. Rich Jones Should we run a funds drive to help pay for the repeater?
 - a. Ron Matusek: Absolutely! We need someone to run the effort.
 - Tom Hoherd: We should be sure that the membership understands why the actions above require \$1500 and why we are running the fundraiser.
- 6. Paul Owen Do we need to have a different mount for the other antenna?
 - a. Paul Kent all the mounts on the building have the same design, which failed this time. Why would we want to mount the antenna in the same way? We probably don't. We would rather get a mount set up where it is accessible.

- iii. Ron Matusek we should drop down to a single net. Perhaps we can consolidate on the more popular / available net (DMR net on Tuesday).
 - 1. Paul Owen Can we move the DMR net to Wednesday instead? Keeps the Wednesday night net intact.
 - 2. Ron Matusek That sounds great! We need some action by the board.
 - 3. Rich Jones Mike Pate has the skills to set up some polls to get feedback from the club membership about the time and location of the net.
 - 4. Rich Jones will take the responsibility to organize a poll about adjusting the net timing and will report back to the Board.
